WHY WE KEEP DATA:

We only retain your data for as long as is necessary and for the purposes specified in this notice. Where you have consented to us contacting you with publicity or fundraising information, you are free to withdraw consent at any time.

The purposes and reasons for collecting and processing your personal data are to contact you about:

- Being or becoming a Friend of the Unicorn;
- Volunteering on the Unicorn;
- Fundraising and fundraising activities; or
- Our activities and the outcomes achieved.

BASIS OF PROCESSING

In becoming a Friend of HMS Unicorn, we have a legitimate and contractual interest in providing you with information about our activities and your Friendship. Among other things we need to be able to advise you of when events are being held.

YOUR RIGHTS

You have the right to access any of your personal information that we process and to request information about:

- What personal data we hold about you;
- Purposes of the processing;
- Categories of personal data concerned;
- Recipients to whom the personal data has/will be disclosed;
- How long we intend to store your personal data for;
- If we did not collect the data directly from you, information about the source.

HOW LONG WE KEEP YOUR DATA

We only ever retain personal information for as long as necessary and we have strict review and retention policies in place to meet these obligations. The data overleaf will be retained indefinitely or until consent is withdrawn.

MAKING A COMPLAINT

If you wish to raise a complaint regarding the processing of your personal data or are unsatisfied with how we have handled your information, you may lodge a complaint in writing to our registered office, email or by telephone. You also have the right to lodge a complaint with the Information Commissioner's Office.
